- **SECRETARY**

- Review minutes from June 2024 meeting
 - Jamie made motion to approve meeting minutes; seconded by Roger; motion approved
- Next meeting will be held Monday August 5, 2024

- **TREASURER**

- Review the Treasurer’s report
 - Approximately \$86k cash on hand
 - \$82,605.81 decrease from 2023 to 2024
 - Should be reimbursed from the DNR soon
 - Largest Expenses:
 - Material deposit
 - Quickbooks, Targets, Main
 - Food license
 - Internet/Tv/Phone
 - Flags
 - Amy made motion to approve Treasurer’s report; seconded by Jamie; motion approved
- Propane contract is the same pricing as last year. Roger made a motion to sign the propane contract; seconded by Jamie; motion approved.
- Grants (DNR)
 - 2024: 5 additional wooden walls on outside 3D course; second handrail for ADA stand; concrete paths to outdoor shooting areas
 - \$2000 grant from the City of Verona
 - 2025 Grant: includes putting a new automated bar with keypad entry at driveway entry; ADA openers for the front entry door and bathroom doors; 30 block targets (to replace indoor, outdoor, NFAA targets); total amount \$67,000.00 they would cover \$50,000.
 - Would like to discuss in the future installation of a bridge at outdoor range target #1
